I'm excited to share with you a **new model** that **will improve your experience** and **improve my ability to be your doctor.** It is a subscription based service which removes insurance companies from controlling my decisions.

The Direct-Patient-Care (DPC) model allows your care to be managed through a combination of electronic communications (such as email or text message) and office visits when necessary, combined with an enhanced annual physical examination. **For an annual fee and small co-pay you can receive all but a very few of the services that have been provided to you previously at no additional cost.**

The new practice will create an improved patient experience; it will be much smaller in size. Office visits can be longer and less pressured. There will be prime flexible appointment hours for your improved convenience. Care will focus around wellness and sickness prevention, emphasizing on

individualized care management. There will always be a person to talk with to help you.

This option will not work for everyone; should you desire a more traditional payment at time of service option, you can sign up for the practice for an annual registration fee of \$149, then pay for each appointment.
